The K'gari (Fraser Island) Bushfire Review Report

Report 1: 2020-21

QUEENSLAND GOVERNMENT RESPONSE

Overview

On 14 October 2020, a vegetation fire was reported at a campground near Orange Creek on K'gari (Fraser Island). The source of the fire was determined to be an illegally lit campfire that was not properly extinguished.

Queensland Parks and Wildlife Service (QPWS) assumed the role of Incident Controller, managing the fire under challenging conditions on remote inaccessible terrain until 27 November 2020 when it was declared a Level 2 Incident and control was handed over to Queensland Fire and Emergency Services (QFES).

During the two-month response, the bushfire travelled from the north of the island southwards towards Kingfisher Bay. It posed a significant threat to townships including Orchid Beach, Happy Valley, Yidney Rocks and The Oaks, in addition to the QPWS base at Dundubara, significant cultural sites for the Butchulla people, and tourist facilities, including the campgrounds at Cathedrals, and the iconic Kingfisher Bay Resort and Village.

QFES, QPWS and Butchulla Aboriginal Corporation (BAC) personnel worked together to contain and extinguish the fire, utilising a combination of QFES assets (Rural Fire Service, Fire and Rescue Service and State Emergency Service) to preserve life, protect property, culturally significant sites, historic structures and the natural flora and fauna.

Significant QFES, QPWS and BAC resources responded to the fire, including ground crews/personnel, firefighting appliances, aircraft and heavy plant, with barges utilised for the transport of personnel and equipment to the Island, throughout the operation.

QFES supplemented the firefighting efforts with 30 different types of waterbombing aircraft during the incident dropping over 13.3 million litres of water on the fire. Despite the large amounts of water dropped by aircraft the fire still took several weeks and rain to be fully extinguished.

The fire received international attention, intense media and public interest due to the site's World Heritage status and its unique flora, fauna and ecosystems.

Review

On 2 December 2020, the Premier and Minister for Trade announced the Office of the Inspector-General of Emergency Management (IGEM) would undertake a review of the K'gari (Fraser Island) bushfire event (the Review).

Terms of Reference (ToR) for the Review and the legislated functions of the Office of the IGEM under Section 16 of the *Disaster Management Act 2003* framed the scope of the Review.

The Review also considered: the cultural and environmental significance of K'gari; recommendations and insights from IGEM's 2018 and 2019 Queensland Bushfires Reviews; recommendations made by the 2020 Royal Commission into National Natural Disaster Arrangements; and was mapped against the relevant Shared Responsibilities of the refreshed Standard for Disaster Management in Queensland (the DM Standard) and informed by the original standard released in 2014.

IGEM recommendations will guide fire management stakeholders in how best to respond to future events and strengthen confidence in Queensland's fire management arrangements.

Queensland's approach to fire management

Traditionally, the bushfire season in Queensland commences in the north of the State in August and concludes in December of each year. A number of factors can influence the length and severity of the bushfire season including the timing and nature of the previous wet season and the current climate outlook.

Over the last three fire seasons (2018, 2019 and 2020) Queensland has seen significant bushfires which resulted in three separate IGEM reviews. Climate change has given rise to a changing environment which in turn means a changing risk profile.

Bushfire prevention and preparedness is a shared responsibility in Queensland and is managed through a partnership between QFES, landholders, local governments, HQPlantations (Queensland's largest plantation forest company) and state and federal agencies, particularly QPWS.

Responsibility for hazard reduction (through activities such as prescribed burns or mechanical fuel reduction) primarily rests with land managers. QFES plays a leadership role in coordination of stakeholders, focussing on reducing the impact of fire on communities.

QFES is the hazard specific lead agency for bushfire and QFES' role in coordinating the efforts of land managers to mitigate bushfire risk is driven through the Office of Bushfire Mitigation, supported strategically by the State Bushfire Committee (SBC), and locally by Area Fire Management Groups. Volunteer Rural Fire Brigades and the volunteer Fire Warden network play a significant role in bushfire mitigation at the local level.

Queensland Government is committed to improving prevention, preparedness, response and recovery capability to meet the challenges ahead.

Queensland Government Response

The review found opportunities for QFES and QPWS to better engage with relevant stakeholders, the Butchulla people and the community, to plan and undertake hazard mitigation activities. This was particularly relevant across multiple land tenures with different landowners, which could benefit from further engagement as part of a reinvigorated Locality Specific Area Fire Management Group on K'gari.

IGEM acknowledged the commitment and fortitude of fire management and response agencies, rural fire brigades, the Butchulla people and community associations on the island in responding to this highly complex and challenging bushfire event that tested response agencies.

The Queensland Government response to the Review recommendations is attached. We commend the report and the Queensland Government response to all stakeholders.
