Message from the IGEM

Welcome to the latest edition of IGEM | Connect.

It has been a very busy year for Queensland. Between November 2021 and May 2022, the state experienced four significant weather events, with a further event in October 2022. IGEM has also had an eventful year; our South East Queensland Rainfall and Flooding Review was tabled in Parliament on 12 October, we hosted our annual Disaster Management Research Forum on 23 September, and kept on top of all of our normal business activities.

I want to personally thank all of our stakeholders for their contributions to the SEQ Rainfall and Flooding Review, and extend my sincere thanks to my team for their efforts, knowledge and professionalism during the review process.



It was a significant piece of work involving almost 250 submissions, 13 community forums and engagement with stakeholders and communities across the 23 affected local government areas.

2023 is also shaping up to be a busy one for IGEM. On 14 December 2022 the Government requested that we conduct a review of Queensland's disaster management arrangements

(QDMA) to inform any changes to the arrangements, legislative reforms, or any updates to the State Disaster Management Plan. This review will also inform the transition of disaster management functions to the Queensland Police Service (QPS) and other relevant agencies. We are looking forward to working with all stakeholders throughout this process.

The severe weather season is also now upon us and we know that when it comes to extreme weather events in Queensland, it's not a matter of 'if' but 'when'. Being prepared before a disaster occurs could be the difference between staying safe or putting yourself and those you love in danger. This includes understanding your risk and ensuring you have a plan to keep you and your family safe in the event of a disaster. The <u>QRA's Get Ready Program</u> is the right place to start.

The latest updates from the Bureau of Meteorology indicate that La Niña will continue into early 2023. As always, IGEM will work in partnership with entities across the disaster management sector to prepare for any future event. Please reach out to the IGEM team should you need any assistance with your organisation's plans or exercises.


Thank you for your partnership this year as we work together to make Queensland a safer and more resilient place for all. We wish you a safe and restful holidays.

South East Queensland Rainfall and Flooding Review 2022

IGEM's review into the South East Queensland Rainfall and Flooding February to March 2022 was tabled 12 October 2022.

This review assessed the effectiveness of preparedness activities undertaken, the timing and effectiveness of Emergency Alerts that were issued, the timing and effectiveness of other communication and information, and the effectiveness of cooperation between agencies regarding the rainfall and flooding event that occurred from 22 February to 7 March 2022. There were 19 recommendations resulting from the review. The Government has been working closely with



IGEM and relevant stakeholders, including local governments, to determine how recommendations can be given best effect.

New review into Queensland's Disaster Management Arrangements

On 26 October 2022, the Minster for Police and Emergency Services and the Minister for Fire and Emergency Services, The Hon Mark Ryan MP tabled the "<u>Independent Review of</u> <u>Queensland Fire and Emergency Services</u>" report, along with the "<u>Sustaining the SES – Partnering for Change</u>" and the "Perview into Volunteer Marine and Persue Organizations

<u>Good</u> Jobs and <u>Better</u> Fire and Emergency Services to in <u>Queensland</u>" reports.

The Minister also tabled the Queensland Government Response to these reviews: "<u>Good Jobs and Better Fire and</u> <u>Emergency Services to Support Queensland's Great</u> <u>Lifestyle"</u>. These review reports and the response are all available on the Queensland Parliament website.

As part of the Government's response, on 14 December 2022 the IGEM has been tasked with conducting a review of Queensland's Disaster Management Arrangements (QDMA). The work to be undertaken by the IGEM will inform any



changes to disaster management arrangements, legislative reforms, or any updates to the State Disaster Management Plan. The review will also inform the transition of disaster management functions to the Queensland Police Service (QPS) and other relevant agencies.

Over the next 18 weeks we will work closely with the Department of the Premier and Cabinet, Queensland Police Service, Queensland Fire and Emergency Services (QFES), Queensland Reconstruction Authority, Department of State Development, Infrastructure, Local Government and Planning, relevant state agencies involved in disaster management, the State Disaster Coordinator (SDC), the Local Government Association of Queensland, and other relevant stakeholders to obtain information necessary to the review.

The IGEM will present a final review report to government for consideration by 29 April 2023. The <u>Terms of Reference</u> are available on the IGEM website.

Stakeholder inputs are critical to the success of this wide-ranging and important review; we look forward to working closely with you through this process.

It was a pleasure to host international delegates and connect with our interstate and regional colleagues at the Asia-Pacific Ministerial Conference on Disaster Risk Reduction.

The conference was held at the Brisbane Convention and Exhibition Centre from 19-22 September 2022, focusing on the theme 'From Crisis to Resilience: Transforming the Asia-Pacific Region's future through disaster risk reduction'.

We welcomed the opportunity to learn from regional neighbours tackling the impacts of concurrent and compounding disasters and reaffirmed the importance of the <u>Sendai</u> <u>Framework for Disaster Risk Reduction 2015-2030</u> which provides for concrete actions to protect from the risk of disasters. The Framework also recognises that responsibility for disaster risk reduction should be shared among diverse stakeholders, including local government, the private sector and other stakeholders.

2021 Australian Bureau of Statistics Census data released

The recently released 2021 Australian Bureau of Statistics (ABS) Census data tells the statistical story of modern Australia and highlights the many changes that have happened in our community since 2016.

The Census data enables agencies to better understand at-risk populations and the needs of different communities in planning for, and responding to, disaster events. The data will also improve understanding of the community's composition, identify risks and assist with preparedness, communication and evacuation plans.

Identifying households without transport, comprised of people who are new arrivals to the community, or who require special assistance, improves planning for vulnerable community members.



Census data can also inform decisions by disaster management staff during an event.
